WE ALSO CONTINUED OUR CLOSE RELATIONSHIPS WITH FEDERAL AND STATE COALITION PARTNERS TO EFFECTIVELY ADVOCATE AGAINST THE ANTI-CHOICE POLICIES PUT FORTH BY THE ADMINISTRATION, CONGRESS, AND CHALLENGING STATES, WHILE LOOKING FOR OPPORTUNITIES TO MOVE PROACTIVE POLICIES FORWARD. SPECIFIC HIGHLIGHTS INCLUDE:

WORKING WITH PLANNED PARENTHOOD FEDERATION OF AMERICA (PPFA) ON AN AMICUS BRIEF IN NIFLA V. BECERRA- STAFF FROM PHYSICIANS ATTENDED THE ORAL ARGUMENTS AND RALLY IN FRONT OF THE SUPREME COURT. DR.
